**FOURTH AMENDED DECLARATION AND RESTATEMENT OF
COVENANTS, CONDITIONS AND RESTRICTIONS FOR CO-OWNERSHIP
INTERESTS**

THIS FOURTH AMENDED DECLARATION AND RESTATEMENT OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CO-OWNERSHIP INTERESTS, made this 16th day of May, 2009 by SHIPS WATCH ASSOCIATION, INC., a North Carolina Corporation, hereinafter referred to as "Association" and the co-owners shown on Exhibit "A" attached hereto and incorporated herein by reference as "Co-owners" (collectively Association and Co-owners as "Grantors").

WITNESSETH:

WHEREAS, Association is the homeowners' association composed of members owning co-ownership interests in the Ships Watch Subdivision located in Atlantic Township, Dare County, North Carolina as more particularly described and delineated on plat recorded in Plat Cabinet B, Slides 256-260, Dare County Registry (hereinafter "Subdivision"); and

WHEREAS, in accordance with the provisions of the Declaration of Covenants, Conditions and Restrictions for Co-ownership Interests recorded in Book 384, Page 653, Dare County Registry as amended by Amended Declaration of Covenants, Conditions and Restrictions for Co-Ownership Interests recorded in Book 461, Page 240, Dare County Registry and as further amended by Second Amendment to Declaration of covenants, conditions and Restrictions for Co-Ownership Interests recorded in Book 1123, Page 103, Dare County Registry, as corrected in Book 1135, Page 870, Dare County Registry and as further amended by Third Amended Declaration and Restatement of Covenants, Conditions and Restrictions for Co-Ownership Interests recorded in Book 1237, Page 395, Dare County Registry (hereinafter collectively "Declaration") said Declaration can be changed or modified by the affirmative vote of owners holding two-thirds (2/3rds) of the co-ownership interests in all the property covered by the Declaration as evidenced by the recordation of an instrument in the Dare County Registry; and

WHEREAS, after due notice to the owners of all co-ownership interests in the subdivision, the Board of Directors the Association proposed to amend said co-ownership Declaration in manner and form as set forth herein; and

WHEREAS, the Association and the owners of record holding two-thirds (2/3rds) of the co-ownership interests in the subdivision, voted by written ballot to amend said Co-Ownership Declaration as proposed and hereinafter set forth, and it is the purpose and intent of this document to memorialize said Amendments as required by the Co-Ownership Declaration.

NOW THEREFORE, the Association, with the approval, affirmative vote and consent of the owners holding two-thirds (2/3rds) of all Co-ownership Interests in the subdivision hereby amend and modify, as stated herein, the THIRD AMENDED DECLARATION AND RESTATEMENT OF COVEANTS, CONDITIONS AND RESTRICTIONS FOR CO-

OWNERSHIP INTERESTS, recorded in Book 1237, Page 395, Dare County Registry, such that all of the Co-ownership Interests in Ships Watch Subdivision as described above shall be held, sold and conveyed subject to the following amended easements, restrictions, covenants, and conditions, which shall run with said properties and be binding on all parties owning all or any part thereof, their heirs, successors and assigns, and which shall inure to the benefit of each owner thereof.

Subparagraph (i) of Paragraph (f) of Section 3 of Article III is hereby removed and stricken from the Third Amended Declaration and Restatement of Covenants, Conditions and Restrictions for Co-Ownership Interest and shall be replaced by the following language which shall constitute the revised subparagraph (i) of paragraph (f) of Section 3 of Article III:

(f) Insurance and Legal

(i) To obtain and pay the costs of all policies of insurance which shall cover such risks, be written by such insurers and be in such amounts as the Managing Agent shall deem proper under the circumstances. All such insurance policies shall cover:

- a. The houses and the common furnishings therein against loss or damage by fire and other hazards customarily covered by fire insurance policies written with extended coverage, together with loss or damage by flooding; and
- b. Any other liability or casualty for which insurance is deemed necessary or desirable by the Managing Agent and which may be reasonably obtained by the Managing Agent.
- c. If the Managing Agent procures such insurance in the name of the Owners of the Co-ownership Interest, then the Managing Agent shall collect, and the Owner shall assign, any proceeds from such insurance policy to the Association for use of said proceeds consistent with this Declaration.

Subparagraphs (i) and (ii) of Paragraph (i) of Section 3 of Article III are hereby removed and stricken from the Third Amended Declaration and Restatement of Covenants, Conditions and Restrictions for Co-Ownership Interest and shall be replaced by the following language which shall constitute the revised subparagraphs (i) and (ii), paragraph (i) of Section 3 of Article III:

- (i) All funds shall be deposited in a management bank account for Ships Watch (the "General Account") with a federally insured financial institution. The Managing Agent shall keep accurate books and records reflecting the amount of such account attributable to each house. Funds deposited in such account may be used by the Managing Agent only for the purposes for which such funds have been collected.
- (ii) Funds which the Managing Agent shall collect for Reserve Expenses, as defined in Section 3 of Article IV, pursuant to this Section shall, within twenty-nine (29) days after deposit in the General Account, be deposited in an interest bearing account with a federally insured financial institution selected by the Managing Agent or invested according to the investment policy duly adopted by the Ships Watch Association, Inc. Board of Directors in U.S. Treasury Bills or Certificates of Deposit of federally insured financial institutions (said interest bearing bank or savings and loan account or Treasury Bills or Certificates of Deposit are all herein collectively referred to as the "Reserve Account") and the Managing Agent shall keep accurate books and records reflecting the amount in the Reserve Account attributable to each house. Funds deposited in the Reserve Account shall be held in trust and may be used by the Managing Agent only for the specific purposes for which such amounts have been collected.

Except as expressly modified herein, all other covenants, conditions and restrictions set forth in the THIRD AMENDED DECLARATION AND RESTATEMENT OF COVEANTS, CONDITIONS AND RESTRICTIONS FOR CO-OWNERSHIP INTERESTS recorded at Book 1237, Page 396 of the Dare County Registry, are ratified and affirmed and shall remain in full force and effect.

IN WITNESS WHEREOF, Ships Watch Association, Inc., has caused this instrument to be executed in its corporate name by their President all by order of the Board of Directors first duly given, and by the vote and approval of owners holding two-thirds (2/3rds) of the co-ownership interests in the subdivision, this the day and year first above written.
