



The undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these articles of incorporation for the purpose of forming a nonprofit corporation under and by virtue of the laws of the State of North Carolina.

Ι

The name of the corporation is OCEANWATCH HOMEOWNERS ASSOCIATION, INC.

II

The period of the duration of the corporation is perpetual.

TII

The purposes for which this corporation is organized are:

- (A) To maintain and administer the common properties and facilities of the Oceanwatch Subdivision, Nags Head Township, Dare County, North Carolina.
- (B) To administer and enforce the covenants and restrictions and to collect and disburse the assessments and charges of said subdivision as same relates to the common properties of the subdivision.
- (C) To conduct such services, duties and functions strictly on a nonprofit basis for the mutual benefit of all lot owners of the Oceanwatch subdivision.
- (D) To operate and conduct the affairs of the corporation in a manner consistent with the requirements of Section 501(C)(3) of the Internal Revenue Code so as to qualify as a non-profit corporation thereunder and under the laws of the State of North Carolina.

IV

The members of the corporation shall be the record owners of the lots and common properties within the Oceanwatch subdivision. The corporation shall have only one class of voting members, the rights of which members shall be designated in the bylaws of this corporation. The directors of the corporation shall be elected by the members in the manner provided by the bylaws.

VI

The street address of the initial registered office and the prinicpal office of the corporation in the State of North Carolina is Kinnakeet Boulevard, Avon, Dare County, North Carolina 27915 and the name of its initial registered agent at such address is George Edward Goodrich. The mailing address of the initial registered office and the principal office is Post Office Box 358, Avon, NC 27915.

VII

The number of the directors constituting the initial board of directors shall be two (2); and the names and addresses of the persons who are to serve as the initial directors are:

George Edward Goodrich James Fuller Dibrell

VIII

Upon dissolution of the corporation, all liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions be made therefor, and the remainder of the corporation's assets shall be distributed among the members according to their respective interests in the corporation.
