All buildings, structures and their appurtenances shall be maintained in a suitable state of repair; and in the event of destruction by fire or other casualty, the premises are to be clear and debris removed within ninety (90) days of such casualty. No advertising signs, or posters, other than a sign advertising property for sale or rent shall be placed on the said lots.
