#### DECLARATION OF CONDOMINIUM FOR BALLAST POINT VILLAS CONDOMINIUM

THIS DECLARATION is made as of April 20 , 1998, by RDANOKE PROPERTIES LIMITED PARTNERSHIP, a North Carolina limited partnership, Post Office Box 1979, Manteo, North Carolina, 27954 (the "Declarant," as hereinafter defined).

Declarant is the Owner of a tract of land and all improvements thereon in Dare County, North Carolina, and is creating a Condominium under the provisions of Chapter 47C of the North Carolina General Statutes, entitled the North Carolina Condominium Act. A maximum of one hundred thirty two (132) residential condominium units will be built on the land called the Submitted Property, which is being Submitted to the North Carolina Condominium Act at this time by this Declaration.

NOW, THEREFORE, Declarant hereby makes this Declaration for the purposes and subject to all the terms and provisions hereinafter set forth.

#### ARTICLE 1

#### DEFINITIONS

1.1 Definitions. The terms defined in Section 47C-1-103 of the North Carolina Condominium Act shall be deemed to have the meanings therein specified whenever they appear in the Condominium Instruments unless the context otherwise requires and except to the extent, if any, that such definitions are changed below. In addition, the other terms defined below shall be deemed to have the meanings specified whenever they appear in the Condominium Instruments unless the context otherwise requires. These definitions shall apply whether or not the defined terms are capitalized.

"Act" means the North Carolina Condominium Act, which is Chapter 47C of the North Carolina General Statutes, as amended.

"Assessment" means the share of the Common Expenses from time to time assessed against a Condominium Unit and its Owner by the Association in the manner herein provided. Look fame

"Association" means Ballast Point Villas Unit Owners' Association, a North Carolina unincorporated association. formed for the purpose of exercising the powers of the Association under the Act and the Condominium Instruments.

"Board of Directors" or "Board" means the board of directors of the Association, which is the governing body of the Association.

"Bylaws" means the bylaws of the Association, as amended from time to time, a copy of the initial Bylaws being attached bereto as Exhibit C.

"Bylaws" may also refer to the Bylaws of the Pirate's Cove Homeowners' Association, Inc., as the context so requires.

"Common Elements" mean all portions of the Condominium other than the Units.

"Common Expenses" means all sums lawfully assessed against the Unit Owners by the Association; expenses of administration, maintenance, repair or replacement of the Common Elements (including Limited Common Elements); expenses ewed to the Pirate's Cove Homeowners' Association, Inc.; expenses agreed upon as Common Expenses by the Association, expenses declared Common Expenses by the provisions of the Act, this Declaration or the Bylaws; and, insurance premiums.

"Condominium" means the Submitted Property submitted to the provisions of the Act by the Condominium Instruments.

"Condominium Instruments" means this Declaration, the Bylaws, the Plat and the Plans, including any and all exhibits, schedules, certifications and amendments thereof, as they may exist from time to time, made and recorded pursuant to the Act.

"Condominium Unit" means a Unit together with the undivided interest in the Common Elements appertaining to that Unit.

"Declarant" means initially Roanche Properties Limited Partnership, a North Carolina limited partnership, which is the fee simple Owner of the Submitted Property and has executed this Declaration.

"Declaration" means this Declaration as amended from time to

"Director" means a Member of the Board of Directors.

"First Mortgagee" means the holder of a first in high wirity Mortgage.

"Foreclosure" includes, without limitation, the judicial foreclosure of a mortgage or the exercise of a power of sale contained in any Mortgage.

"Unit Designation" means one or more numbers and/or letters that identify each Unit, as set forth in the Schedule of Unit Information, and as shown on the Plat and Plans.

"Institutional Mortgagee" means one or more commercial or savings banks, savings and loan associations, trust companies, credit unions, industrial loan associations, insurance companies, pension funds, or business trusts including, but not limited to, real estate investment trusts, any other lender regularly engaged in financing the purchase, construction, or improvement of real estate, or any assignee of loans made by such a lender, or any combination of any of the foregoing entities.

"Lease" means any lease, contract, tenancy, sublease, rental contract or other occupancy agreement whether oral or written.

"Limited Common Elements" means a portion of the Common Elements reserved for the exclusive use of one or more, but less than all, of the Units.

"Majority" means more than fifty (50%) percent in any context, unless a different percentage is expressly required.

"Mortgage" means a mortgage, deed to secure debt, deed of trust, security agreement or other instrument conveying a lien upon or security title to a Condominium Unit as security for a debt or for the performance of an obligation.

"Mortgagee" means the holder, guarantor, insurer of a Mortgage or a beneficiary under a Deed of Trust.

"Occupant" means any person, including, without limitation, any guest, invitee, tenant, lessee or family Member of an Owner, occupying or otherwise using or visiting in a Unit.

"Officer" means an officer of the Association.

"Owner" has the same meaning as Unit Owner.

"Flans" mean the plans for the Condominium which are certified and filed for record as indicated on the cover page hereof, as amended and certified from time to time; with a copy of the initial Plans being attached hereto as Exhibit P.

"Flat" means the plat of survey for the CondOminium Fiftch is certified and recorded as indicated on the coverigine in the amended and certified from time to time, with a copy of the initial Plat being attached hereto as Exhibit E.

"Record" or "file for record" means filing for record in the Office of the Register of Deeds, Dare County, North Carolina.

"Schedule of Unit Information" means the schedule attached hereto as Exhibit B, which schedule shows for each Condominium Unit its Identifying Number, model type, undivided interest in the Common Elements, number of Votes in the Association, and share of liability for Common Expenses.

"Size" means the number of square feet of heated, enclosed floor space in a Unit as computed by reference to the Plat and Plans and rounded off to a whole number. Enterior walkways and breezeways are not included. Enclosed and heated stairways are counted, but only on one level.

"Submitted Property" means the Property lawfully submitted to the provisions of the Act and the Condominium Instruments from time to time by the recordation of Condominium Instruments in accordance with the Act. The Submitted Property is the land described in Exhibit A and shown on the Plat, together with all improvements thereon and all rights and easements appurtenent thereto.

"Unit" means a portion of the Condominium intended for independent ownership and use, as more fully set forth and shown in the Condominium Instruments and the Act.

"Unit Owner" has the same meaning as Owner and means one or more persons, including the Declarant, who own a Condominium Unit. This term does not include a Mortgages in his capacity as such, but shall include any person, firm, corporation or entity capable of holding title to real estate in North Carolina.

"Unscld" shall mean unconveyed.

"Vote" means the Vote in the Association apportaining to each Condominium Unit.

#### ARTICLE 2

## CREATION OF THE CONDOMINIUM

2.1 Submission to the Act. Declarant hereby submits the Submitted Property to the Act. The Submitted Property and every interest therein shall, after the recording of this Declaration, be owned, held, transferred, sold, conveyed, used, leased, occupied, mortgaged and deeded in trust subject to the Act and

the Condominium Instruments. Every person acquiring of liquid or any interest in the Submitted Property, by acceptable of liquid or other instrument of any kind, whether or not such deed or other instrument is signed by such person or otherwise agreed to in writing, shall take such interest subject to the Act and to the Condominium Instruments and shall be deemed to have agreed thereto.

- 2.2 Name and Location. The name of the Condominium is "Eallast Point Villas Condominium." The Condominium is located on Pirate's Way in Pirate's Cove which is situated in Dare County, Worth Carolina, along U.S. Highway 64/264 on Nags Head-Manteo Caussway, in or near the Town of Manteo.
- 2.3 Governing Provisions. The Condominium, the Association and each Unit Owner shall be governed by the Act, the Condominium Instruments and any rules and regulations adopted by the Association pursuant to the Condominium Instruments, and by the Bylaws of the Firste's Cove Homeowners' Association, Inc.

#### ARTICLE 3

# DESCRIPTION OF THE CONDOMINIUM

- described on Exhibit A and shown on the Plat, and it includes all improvements thereon and all rights and easements appurtenant thereto. The improvements may include up to nine (2) buildings with each building containing a varying number of Units. Such buildings may contain a total of up to one hundred thirty two (132) tifteen (15) Units.
- 3.2 Condominium Units. The Condominium may contain up to one hundred thirty two (132) Condominium Units, the Identifying Numbers of which are set out on the Schedule of Unit Information and are shown in the Flats and Flans. Each Condominium Unit consists of the Unit together with its undivided interest in the Common Elements. The Schedule of Unit Information sets forth for each Condominium Unit its Identifying Number and undivided interest in the Common Elements, Vote(s) in the Association, and share of liability for Common Expenses. All Units are external covering consists of concrete or lap cedar siding, while the roof finish is architectural grade asphalt shingles. Each Condominium Unit shall constitute for all purposes a separate parcel of real property which may be owned in fee simple and which, subject to the provisions of the Act and the Condominium Instruments, may be conveyed and encumbered like any other purporty. The undivided interest in the Common Elements for each Condominium Unit shall not be altered except as expressly provided by the Act and this Declaration. Such

undivided interest shall not be separated from the Whit to which it appertains and shall be deemed to be conveyed or encumbered with the Unit even though such interest is not expressly mentioned or described in the conveyance or other instrument. Each Unit Owner shall automatically be a Member of the Association, which Nembership shall continue during the period of Ownership of the Condominium Unit by such Unit Owner.

3.3 Unit Boundaries. Each Unit shall include all the space within the boundaries thereof. The perimetrical or vertical boundaries of each Unit are the vertical planes of the interior surfaces of the wood framing of the walls of the Unit, whether such walls are exterior walls or walls separating the Unit from other Units or the Common Elements, and the vertical planes of the exterior surfaces of windows and entry doors, including sliding glass doors, if any. The perimetrical Unit boundaries include the sheet rock on the Unit side of the walls, with the framing being a part of the Common Elements, and they are extended to their intersection with each other and the upper and lower horizontal boundaries of the Unit. The lower horizontal boundary of each Unit is the plane of the upper surface of the sub-floor of that Unit, and the upper horizontal boundary of each Unit is the lower surface of the ceiling joists of the Unit, with such sub-floor and framing being a part of the Common Blements. The upper and lower boundaries of each Unit include the wood, dry-wall, plaster or other material forming the ceiling or floor, as may be applicable, on the Unit side of such sub-floor or framing as the case may be and extend to their intersection with the perimetrical boundaries of the Units. Window screens and all fixtures, equipment and appliances located within the boundaries of each Unit, including without limitation, portions of the heating and sir-conditioning system and the hot water heater are deemed to be a part of each Unit. If any chutes, flues, ducts, conduits, wires, pipes or any other apparatus lies partially within or partially outside of the designated boundaries of a Unit, any portions thereof which serve only that Unit shall be deemed a Limited Common Element of that Unit, while any portions thereof which serve more than one Unit or any portion of the Common Elements shall be deemed a part of the Common Slements. Further, any fan coil unit mounted above the ceiling of a Unit and the air-conditioning/heating unit located outside the Unit but serving that Unit only shall be deemed to be a part of that Unit. In interpreting the Plans, the existing physical boundaries of a Unit as originally constructed or of a Unit reconstructed in substantial accordance with the original Plans thereof shall be conclusively presumed to be its boundaries rather than the metes and bounds expressed in any Plat or Plans, regardless of settling or lateral movement of the building and regardless of minor variance between the boundaries shown on the Plans or in a deed and those variances between the boundaries shown on the Plans or in a deed and those of the Unit. If an Owner acquires an adjoining Unit, thereby becoming the Common

Owner of adjoining Units, such Owner shall neve the right (subject to the prior written approval of the Mortgages of the Units involved) to remove all or any part of any intervening partition or to create doorways or other spertures therein. notwithstanding the fact that such partition may, in whole or in part, be part of the Common Elements, so long as no portion of any load bearing wall or column is materially weakened or removed and no portion of any Common Elements. other than that partition and any chutes, flues, ducts, conduits, wires or other apparatus contained therein which shall be relocated by such Owner if such facilities serve any other part of the Condominium, is damaged. destroyed, or endangered. The alterations permitted by the preceding sentence shall not be desmed an alteration or relocation of boundaries between adjoining Units, nor an alteration of the allocated interest in the Common Elements, Vote assigned to each Unit, share of liability for Common Expense assessments or other appurtenant rights or interests as such appears on the Schedule of Unit Information attached hereto as

- Common Elements. The Common Elements consist of all portions of the Condominium other than Units. Certain portions of the Common Elements are Limited Common Elements, as set out in Section 3.5. The Unit Owners Association and the Owners agree that said Common Elements shall not be subject to partition or division except as set out as follows:
- 3.4.1 Notwithstanding any provisions herein to the contrary, it is expressly provided that the Association may convey to the Declarant any portion of the Common Elements theretefore conveyed to the Association in exchange for other portions of the properties conveyed by the Declarant to the Association provided that all conveyances are approved by appropriate governmental authority or in their failure to act timely by the Board of Directors of the Association, Upon such conveyance, the area thus conveyed to the Declarant shall cease to be Common Element and shall cease to be subject to the provisions of these covenants relating to the Common Elements. but the area thus conveyed to the Association shall become Common Elements and subject to the provisions of this Declaration relating to Common Elements.
- Limited Common Flements. The Limited Common Elements are those portions of the Common Elements which are reserved for the exclusive use of those persons who are entitled to the use of one or more (but less than all) of the Units. Limited Common Elements are not separate and apart from the Common Elements in general, but are limited only with respect to the exclusive use thereof by the Unit or Units to which they are assigned. Limited Common Elements are assigned as follows and not otherwise:

- 3.5.1 The exterior stairways, steps, breticitys, (all ways, parking areas underneath buildings, landings, rathings and beams associated therewith which serve a building and the canvas doorway awnings, which are appurtenant to each Unit having any of the foregoing, shall be Limited Common Elements assigned to the Unit or Units having direct access thereto or direct use thereof. If a walkway, steps or other means of access to the oper of a Unit is assigned to serve one or more (but less than all) of the Units, then it shall be a Limited Common Element appurtenant to the Unit or Units so served.
- 3.5.2 All portions of the Common Elements on which there is located any portion of the heating and air-conditioning system exclusively serving a particular Unit or Units shall be a Limited Common Element assigned to that Unit or Units.
- 3.5.3 The Board of Directors of the Association shall have the ultimate power and responsibility for determining whether Limited Common Areas in need of repair are to be the obligation of the entire Association or the obligation of the Owners of the Units which those Limited Common Elements serve. The Board may, majority Vote, determine the amount and levy any special assessments for repairs of Limited Common Elements consistent with its determination pursuant to this paragraph.
- Development Rights. The Declarant has planned for a maximum of one hundred thirty two (132) Condominium Units to be constructed on the Property Submitted herein to a Condominium regime. In this regard, as of the date of filing for record of this Declaration of Condominium, the Declarant may not have constructed all one hundred thirty two (132) Units and such improvements as should be considered a part of the Common Elements or himited Common Elements. Reference is hereby made to the Plats and Plans attached hereto as Exhibits and made a part hereof, which Plats and Plans will show the location, size, and dimensions of the entire Condominium once completed. The Declarant reserves the right to develop and construct the Units and improvements shown on the Plats and Plans and to have such Units deemed to be separate Units and not a part of the Common Elements. Such Units will be built, if at all, within twenty (20) recorded to be recorded to be be built. (20) years of the recordation of this Declaration of Condominium. Declarant further reserves the right and option to withdraw from the Condominium any and all of those portions of the Submitted Property as "Withdrawable Land" noted on the Plats and Plans without the consent of any Unit Owner or mortgagee and at any time. The right to withdraw may be terminated only upon the filing of an amendment to the Declaration by the Declarant. The development rights herein reserved may be exercised with respect to different portions of the Submitted Property at different times. No assurances are made as to the boundaries of those portions or the order in which those portions may be subjected to the exercise of each development right. When adding Units to the

Condominium, or when withdrawing portions of the California property, the Declarant may modify, after, combine, delate and absolute discretion. No assurances are given that if a development right is exercised with regard to one portion of the Gubmitted Property subject to development rights will be exercised in all or in any other portion of the remainder of the Submitted Property. No assurances are given that if development rights are exercised that they will be exercised on contiguous parcels. Any and all Withdrawable Land, and portions thereof, that is (are) withdrawn from the Condominium may be used by the Declarant for any other lawful purpose.

With regard to those Units and improvements shown on the Flats and Plans which have not been completed as of the date of filing for vacord of this Declaration of Condominium, they MEED NOT BE BUILT, and the Declarant hereby reserves the right to refrain from the development and construction of such Units. In the event the Declarant chooses not to develop and construct any of the one hundred thirty two (132) Units or other improvements shown on the Plats and Plans, the area where such Units or improvements were to be constructed shall be deemed part of the Common Elements of the Condominium unless withdrawn from the Condominium by the Declarant. Such election by the Declarant Will increase each Unit Owner's pre-rate share of Common Expenses and assessments to one over the number of Units actually constructed and added to the Condominium regime (1/# Units

The Declarant reserves hereby privilege and easement to construct docks, piers, and boat slips adjoining the Submitted Property along the canal on the western edge of the Submitted Property. Such improvements shall be owned by the Pirate's Cove Homeowners! Association, Inc. and shall assigned for the use and enjoyment of those Class A Members the Pirate's Cove Homeowners' Association, Inc. in good standing. The docks, piers, and boat slips so constructed shall not be a part of the Common Elements of the Condominium, but shall be assigned solely to Owners in Pirate's Cove pursuant to the rules and regulations of the Firate's Cove Homeowners' Association, Inc. that Owners shall not be entitled to a boat slip and may only be assigned a boat slip subject to availability and in accordance with the rules and regulations of the Firate's Cove Bomeowners'

The Declarant hereby reserves unto itself, its agents, employees, successors and assigns any and all easements and accesses necessary over and through the Submitted Property and any adjoining lands for the building, developing and completion of Pirate's Cove according to its master plan, which may be amended at Declarant's sole option. The Declarant hereby reserves the right to develop and improve land and properties in

Dirate's Cove as it, in its sole discretion, shall deem proper the Declarant reserves the right to create additional Condominium regimes or other planned communities in Pirate's Cove and to add such to the area governed by the Pirate's Cove Homeowhere's develop approximately 627 residential units in the residential area of Pirate's Cove, whether those residential tots, but no assurances are given that any or all of such units shall be constructed or developed. To the extent any such units are completed or developed, they will be added to the areas governed and maintained by the Pirate's Cove Homeowners' Association, Inc., and the Owners thereof will be obligated to Association.

Pirate's Cove Home Daners' Association, Inc. The real estate submitted to a condominium regime herein is a part of a larger planned community and development to be built upon lands owned by the Daclarant to be known as Pirate's Cove. The Declarant has caused to be created and incorporated a property owners' association, known as the Pirate's Cove Homeowners' Association, Inc. (hereinafter "PCEA") to which each Condominium Unit Owner must belong and contribute. The duty of this property owners' association is to insure and maintain the overall integrity of the development and to own, maintain, repair and replace the roads, streets, bridges, docks, piers, boat slips, utility facilities and recreational amenities and facilities owned by or entrusted to it by the Declarant or Association. These facilities hereinbefore mentioned Che be a part of the Common Elements of the Condominium. All Unit Owners are Members of said Association. Each Unit is hereby allotted one (1) Vote in the said Association and such Vota shall be as a Class A Member, as such is defined in the By-Laws of the FCMA, which are attached hereto incorporated by reference herein. as Exhibit "D"

The PCHA shall have the right and power to maintain and improve all streets, roads, and parking areas located within the Submitted Property and to charge the Unit Owners' Association for its pro-rata share of the costs of such maintenance and improvements.

The PCHA shall maintain Pirate's Way and shall divide the costs of such maintanance among the property owners and others operating businesses in the commercial area of Pirate's Cove and property owners in the residential area of Pirate's Cove according to the estimated average daily number of motor vehicles using Pirate's Way to access the commercial and residential areas of Pirate's Cove.

The PCHA shall own, maintain, repair and retlace the docks, piers, and boat slips which are immediately adjacent to the Submitted Property. The right and privilege for the use, and each Hamber in good standing in the PCHA, of which each Unit Cwner is a Member. In accordance with the Ey-Laws of the PCHA, each Unit Owner will become a Member of the PCHA, as a Class A Member, upon conveyance to such Unit Cwner of a deed in ise simple title to that Unit. The PCHA shall have the right and duty to charge the Unit Comers' Association for its pro-rate share of the slips or assess such costs on a pro-rate basis among the Class A Members of the PCHA as is more fully explained in the By-Laws of the PCHA. The docks, piers and boat slips located along the western boundary line of the Submitted Property shall be assigned solely to Cwners in Pirate's Cove.

In the event the Declarant shall at any time provide any services for potable water and sewage, garbage and trash pickup, and street, sidewalk and street lighting maintenance to the Condominium Units, the Declarant is hereby given and granted the right, in its sole discretion, to assign and transfer its duties and obligations of providing such services to the PCMA along with all of Declarant's right, title, or interest to any service facilities the Declarant may have.

The Submitted Property has been annexed by the Town of Mantec. The Declarant and the Town of Manteo have entered into an agreement to assure that water and sewage services are provided to the Condominium Units. Each Unit Owner will be responsible for the costs of water and sewage services to their individual Unit(s), or will share the costs thereof as Common Expenses of the Unit Owners' Association or the PCHA. The said agreement for water and sewage services obligated the Declarant to make payments for the benefit of the Town of Manteo to facilitate the construction by the Town of Manteo of wastewater treatment facilities adequate to meet the needs of Pirate's Cove.

Trash and garbage pickups by the Town of Manteo will be by means of the use of dumpsters. Door-to-door pickup will not be provided by the Town of Manteo. Throughout Pirate's Cove, the Declarant or the PCHA and not the Town of Manteo will provide trash or garbage pickup which requires special handling, e.g. fish carcasses.

The Declarant or the FCHA shall provide street, sidewalk and street lighting maintenance for the Condominiums, and such shall not be the responsibility of the Town of Manteo.

The Condominium will be supplied potable water by the Town of Manteo and the cost thereof may be billed to the Unit Owner, the Unit Owners' Association or the PCHA, in which event, it shall

become a Common Expense of the Association bidity of Unit Owner may be obligated to pay any tep-on or impact fees for water or sewage hookup, in the event such fees are required and are not otherwise imposed by the Town of Manteo provided by the Declarant.

Electrical services will be provided to each Unit by a public utility and cost thereof will be billed to each Unit Owner. Portions of the Condominium and Pirate's Cove will be supplied water and electrical services for the purposes of the PCHA, and the PCHA shall have the right and duty to charge the Unit Owners' Association for such water and electrical services, in which case it shall become a Common Expense of the Unit Owners' Association.

The PCHA shall own, maintain, repair and replace all such other improvements, amenities, and recreational facilities in Pirate's Cove as shall be constructed by the Declarant and transferred and conveyed to the PCHA, or as shall be constructed and maintained by the PCHA. The PCHA shall have the option of charging the Unit Owners' Association its pro-rata share of the costs and expenses of constructing and maintaining the improvements, amenities, and recreational facilities owned or maintained by the PCHA, (in which case it shall become a Common Expense of the Unit Owners' Association), or of charging such costs and expenses to the individual Unit Owners as Class A Members of the PCHA.

In the case of all costs, expenses, and charges which are hereby made payable by the Unit Owners' Association to the PCHA. the amount to be borne by each Unit Owner shall be equal to the Unit Owner's percentage interest in the Common Elements of the Condominium. The amounts of all such charges, costs and expenses which will be charged by the PCHA to the Unit Owners Association shall be determined by multiplying the entire costs or expenses of the PCHA by the fraction of the number of Units in the Condominium over the total number of Votes of the PCHA Class A Membership. The Class A Membership of the PCMA shall consist of one (1) Member for each residential Unit in Pirate's intended for and restricted occupation, whether such residential 1.0 single-family Units, townhouse Units, or single-family lots and improvements. The Declarant shall have the option to pay, in its sole Condominium discretion, for the actual operating costs and expenses in excess of the collections of assessments herein provided for to the extent that said excess would be otherwise payable for Condominium Units then remaining unsold and being still owned by the Declarant.

The PCHA shall not be deemed a Master Association as that term is defined in Section 47C-2-120 of the Act. The PCHA shall have, in addition to those powers, duties, and obligations herein specifically enumerated, all the powers enumerated in the Bylaws of the PCHA, which may be invoked to the extent the PCHA

The Pirate's Cove Homeowners' Association, Inc. is hereby granted the absolute and exclusive right to maintain, control and assign the docks, piers and boat alips throughout the residential area of Firate's Cove, including those adjacent to the Condominium on the docks, piers and boat slips adjacent to the Condominium on the west side may be used by and assigned solely to the Owners in hereby granted the right and option, in its sole discretion, to charge and assess the Unit Owners in this Condominium alone for the costs of maintenance, repair and upkeep of the docks, piers and boat slips adjacent to the Condominium. No boat or other vessel or craft shall be docked or moored in the waterways and canals in Pirate's Cove so as to block or hinder the reasonable access, ingress and egress of others. Mo boat or other vessel or craft over fifteen feet (15') wide, measured at the "beam", shall be allowed in the residential area of Pirate's Cove, unless it shall first seek and obtain the prior of Directors of the Board of Directors of the PCHA. The Board of Directors of the PCHA may, by appropriate resolution, make such other and further rules and regulations concerning the use and enjoyment of the docks, piers, boatslips, canals and deem fit and proper.

A Unit Owner in this Condominium shall become a Class A Member of the Firate's Cove Homeowners' Association, Inc. This Association has been created to provide a comprehensive and uniform method for managing, owning, and maintaining the common areas and properties of Firate's Cove, which may, but need not, include:

- a) Pirate's Way, and other roads, streets and parking areas in the residential area of Pirate's Cove;
- b) the docks, piers and boat slips located in the residential areas of Firate's Cove;

No assurances are given that any or all of these amenities will be provided, except the roads and streets accessing the Condominium to and from U.S. Highway 64/164. However, to the extent these smenities are provided, each Unit Owner will be obligated to pay to the Pirate's Cove Homeowners' Association, a pro rata assessment for the Common Expenses of the said association, to be paid quarterly in advance.

In the event a conflict or dispute shall arise between the Association and the Firate's Cove Homeowners' Association, Inc. shall have the absolute right, by majority vote of its Class A Nembers, to resolve the conflict or dispute.

The Pirate's Cove Homeowners' Association, Inc. is hereby given the right to enforce the terms and provisions of this Declaration and to suspend the rights and privileges of Class A Members of said Association who are also Unit Owners in this Condominium. The terms and provisions concerning the suspension of rights and privileges are contained in the By-Laws of the PCHA, which are incorporated by reference herein.

Notwithstanding anything contained herein to the contrary, the Daclarant, Roanoke Properties Limited Partnership, its successors and assigns, shall have the right to appoint and designate the entire Board of Directors of the Pirate's Cove Homeowners' Association, Inc. until January 1, 2003. Said Board of Directors shall have all powers given and granted by this Declaration, the Bylaws of the Pirate's Cove Homeowners' Association, Inc. and all meeting of the Membership of the said Association after January, 2003, the Board of Directors shall be elected as set forth in Section 1.A. of Article I of the Bylaws of the Firate's Cove Homeowners' Association, Inc.

#### ARTICLE 4

## EASEMENTS

In addition to the easements created by the Act, the easements described in this Article 4 from each Owner to each other Owner, to the Association, to the Pirate's Cove Homeowners' Association and to the Declarant are hereby granted, reserved and established, subject to and in accordance with the following terms and conditions:

4.1 Use and Enjoyment. Every Owner shall have a right and easement of use and enjoyment in and to the Common Elements (including the right to access, ingress and egress to and from his Unit ower those portions of the Common Elements designated for such purpose), and such easement shall be appurtenant to and shall pass with the title to every Condominium Unit, subject to

the following provisions and limitations:

- 4.1.1 The right of the Association to control the use and enjoyment thereof as provided by the terms of this Declaration, which shall include, but not be limited to, the right of the Association to limit the use and enjoyment thereof to the Owners and their respective Occupants, as well as to provide for the exclusive use and enjoyment of specific portions thereof at certain designated times by an Owner and his Occupants.
- 4.1.2 The right of the Association to limit the number of guests of Owners.
- 4.1.3 The right of Owners to the exclusive use of the Limited Common Elements appurtenant to their respective Units.
- Vote and the right to use any recreation to suspend the right to Condominium by the Owner and his Occupants and Common Area appurtenant thereto for any period of time during which an Assessment against his Condominium Unit remains unpaid or for a Condominium Instruments or rules and regulations.
- 4.2 Sinustural Support. Every portion of a Unit or the Common Elements which contributes to the structural support of another Unit or the Common Elements shall be burdened with an easement of structural support. No Owner shall be permitted to demolish his Unit except to the extent that such demolition may be required to repair or rebuild the Unit when the same has been partially or totally destroyed.
- 4.3 Etilities. To the extent that any utility line, pipe, wire or conduit serving any Unit, Units or the Common Elements shall lie wholly or partially within the boundaries of another Unit or the Common Elements, such other Unit, Units or the Common Elements shall be burdened with an easement for the use, wire or conduit, such easement of such utility line, pipe, or Common Elements served by the same and the Association.
- 4.3.1 Declarant reserves the right to subject the real Property described hereinabove to a contract with N. C. Power Company for the installation of underground electric cables and the installation of street lighting, either or both of which may require continuous monthly charges to the Owner of each Condominium. Should any utility furnishing a service covered by the general easement herein provided request a specific easement by separate recordable document(s), Declarant or the Association, in the easement crosses property covered by the Unit Owners' Association, will have the right and authority to grant such easement on said property without conflicting with the terms hereof. Each Unit Owner shall perform his responsibilities in such a manner so as not to unreasonably disturb other persons in other Units and shall keep the exterior entrance area adjoining his Unit in a neat and clean condition and free of standing water. Each Unit Owner shall promptly report to the Association or its agent any defect or need for repairs for which the Association is responsible. The Association shall have the right but not the obligation to make any repair or replacement or to do any cleaning or maintenance which is the responsibility of the Unit Owner if the Unit Owner fails or refuses to do so, and in such event obligated to pay for the cost incurred by the Association for such work. The Board of Directors shall have the sole right by majority vote to determine when any such repairs or replacements are made. The sums spent by the Association pursuant to this authority shall be conclusive upon the Unit Owner(s) to be assessed. Each Unit Owner shall also be obligated to pay for the cost of repairing, replacing, or cleaning any item which, although the responsibility of the Association, is necessitated by reason of the willful or negligent act of such Unit Owner or any of his Occupants. The cost of any such repair, replacement, maintenance or cleaning shall be added to and become part of the Assessment or portion thereof next coming due to which the Unit Comer is subject and shall constitute a lien against the unit in like manner as other assessments.

#### ARTICLE S

#### **ASSESSMENTS**

- the Association all Assessments (general and special bimited Common Element assessments, or any other assessments properly levied by the Association) provided by the Act and by this Declaration which shall be fixed, established and collected from time to time as hereinafter provided. All Assessments and other charges provided by this Declaration, together with interest shall be a charge squinst and continuing on his Unit while he is the Doner. Any Unit shall be conveyed subject to a lien for any unpaid Assessments subject to the provisions of Section 47C-3-116 of the Act and Section 6.7 hereof. No Owner may non-use of the Common Elements or abandonment of his Unit. Notwithstanding any other provision contained in this Declaration, the Declarant may choose to be responsible for all Common Expanses until the end of the period of Declarant control or until the Unit time the Declarant will be bound to contribute to Common Expanses Units which remain unsold.
- Expenses not specially assessed against one or more but less than all of the Condominium Units pursuant to the provisions of this Declaration. less the amount of all undistributed and unreserved excess of Assessments and other income over expenditures, shall be assessed against the Condominium Units in accordance with the Schedule of Unit Information. The general annual Assessment shall be established by the Board of Directors in the manner set forth in this Section. During that portion of the Association's fiscal shall be as set forth in the estimated budget for the Condominium Unit dalivered to each purchaser of a Condominium Unit. Prior to any change in assessment, the Board of Directors shall prepare and submit in writing to the Owners an estimated budget of the Common Expenses for the next succeeding fiscal year to be paid by Assessments collected from the Owners, together with the amount of

the annual Assessment payable by each Owner during accidentally year. If the estimated budget proves inadequate nor any Classon at any time during the year, then the Board of discutous day levy at any time a further Assessment against the Owners and notify the Owners accordingly. If for any reason an annual budget is not prepared by the Board, a payment in the amount required by the last prior Assessment shall be due upon each Assessment due date until changed by a new Assessment. Common Expenses of the Association to be paid through annual Assessments shall include, but shall not necessarily be limited to, the following Sections 6.2.1 through 6.2.9. Inclusive, and the due date(a) of any such special Assessments shall be specified by the Board of Directors.

- 6.2.1 management fees and expanses of administration, including management, legal and accounting fees.
- 6.2.2 Utility charges for utilities serving the Common Elements and charges for other common services.
- 6.2.3 The cost of any master or blanket policies of insurance purchased for the benefit of all Owners and the Association as required by this Declaration, including fire and other hazard coverage, public liability coverage, and such other insurance coverage as the Board of Directors determines to be in the interest of the Association and the Owners.
- 6.2.4 The expense of maintenance, operation and repair of the Common Elements as well as any maintenance upon the Units which is the responsibility of the Association under the provisions of Article 5. if such expense is not covered by a special Assessment.
- 6.2.5 Charges for any utilities provided to the Units and not separately metered which shall be a Common Expense of the Association.
- 6.2.6 Such other expenses as may be determined from time to time by the Board of Directors to be Common Expenses, including, without limitation, taxes and governmental charges not separately assessed against each Condominium Unit, other than advalorem real property taxes.
- 5.3.7 The establishment and maintenance of an adequate reserve fund or funds for the periodic maintenance, repair and replacement of those Common Elements (including Limited Common Elements) which the Association may be obligated to maintain and of a reserve to cover operating contingencies or deficiencies arising from unpaid Assessments or liens, emergency expenditures and other matters, as may be authorized from time to time by the Board of Directors.

- 6.2.8 Expenses declared Common Expenses by the provisions of
- Assessments of the Pirate's Cove Homeowners' Association, Inc. as are herein provided for or as may hereafter be agreed upon by the Pirate's Cove Homeowners' Association, Inc. to be billed quarterly in advance. Such shall include, but not be limited to, the costs of constructing, maintaining, repairing, and replacing the roads, streets, parking areas, bridges, docks, piers, boat slips, recreational facilities, common amenities, sewer facilities and much other property rights in Firate's Cove owned by or entrusted to the Firate's Cove Homeowners' Association.

The general annual assessment for Common Expenses described above shall be paid by and collected from the Owners in accordance with their respective liabilities for Assessments. Each Owner shall be obligated to pay such Assessments to the Association in quarterly installments on or before the first day of every third month, beginning with Jenuary 1 of each year. In any year in which there is an excess of Assessments and other income over expenditures, the Board of Directors, by resolution and without the necessity of a Vote of the Owners, shall determine either to apply such excess or any portion thereof against and reduce the subsequent year's Assessments or to allocate such excess to one or more reserve accounts of the Association described above. Any of the foregoing previsions of this paragraph which may be construed to the contrary notwithstanding, no Assessment shall be payable under this paragraph by any Owner until this Declaration is filed for record. Therefore, the first annual Assessment payable under this paragraph shall be prorated according to the number of days remaining in the Association's fiscal year after the date on which this Declaration is filed for record.

5.2 Special Assessments of Association. Any Common Expenses occasioned by the conduct of less than all Unit Owners or their Occupants may be specially assessed by the Board against the Condominium Unit or Units, the conduct of any Owner or occupant of which occasioned any such Common Expenses. Notwithstanding anything to the contrary set forth herein, except as provided in Section 5.2, there shall be no special Assessments against any particular Condominium Unit for any Common Expenses associated with the maintenance, repair, restoration, renovation or replacement of any Limited Common Elements; rather, such expenses shall be Common Expenses. #### ARTICLE 9

# RECONSTRUCTION OR PEPAIR OF CASUALTY DAMAGE

In the event of damage by fire or other casualty to the Submitted Property or any part thereof, the provisions of this article and Section 47C-3-113 of the Act shall govern the repair and reconstruction. The terms "repair" or "reconstruction" as used herein shall mean repairing or restoring the Submitted Property to substantially the same condition in which it existed prior to the fire or other casualty (excluding improvements and betterments made by an Owner or Occupant) with each Unit and the Common Elements having the same boundaries as before. In the case of a casualty causing damages or destruction to a Unit and/or Common Elements serving Discharge of Unit, such damage or destruction (including any damage or destruction to any Common Elements serving exclusively such Unit) shall be repaired or reconstructed unless each of the following occur: (i) there is a substantial loss of all the Units (including any damage or destruction to any Common Plements serving exclusively such Unit) contained in any one (1) building in the Condominium; and (ii) within sixty (60) days of such casualty, 100% of the Owners of damaged or destroyed Units and 80% of all Owners vote and agree in writing not to repair or reconstruct. Should the Owners so decide not to repair or reconstruct damaged or destroyed Units, then such damaged or destroyed Units shall not be repaired or reconstructed and the provisions of Section 470-3-113(h) of the Act shall govern and control the Ownership of such demaged or descroyed Units. The undivided interest in the Common Elements, votes in the Association and share of liability for Common Expenses appertaining to such Condominium Units shall thenceforth appertain to the remaining Condominium Units on the basis of an equal share per Unit.
- 9.1.4 Extension of Time. If for any reason the amount of insurance proceeds to be paid as a result of a casualty, or reliable and detailed estimates of the cost of repair or reconstruction of such casualty, are not made available within period specified above shall be extended until such information is made available; provided, however, that such period of time shall in no event exceed One Hundred Twenty (120) days after such casualty.
- 9.1.5 Annication of Proceeds: Common Blaments and Units Not Repaired. If it is determined in accordance with the provisions hereof that any damaged Common Elements not serving exclusively a Unit shall not be repaired or restored, then the insurance proceeds appertaining thereto shall be divided among the Owners in accordance with their percentage or fractional interests in the Common Elements. If it is determined in accordance with the provisions hereof that any damaged Unit shall not be repaired or restored, then the insurance proceeds appertaining thereto shall be paid to the Owner of such damaged Unit in proportion to the total damage for which proceeds are received, and thereupon such Owner shall have no further right, title or interest in the Condominium. In all cases where there is a Mortgages endorsement with respect to a Unit, any insurance proceeds shall be disbursed to the Owner and such Mortgagee jointly, who shall use such proceeds as they alone may determine. This is a covenant for the benefit of any such Mortgagee and may be enforced by any such Mortgagee. The Association shall cause the debris to be removed from any area on which was located a damaged Unit or damaged Common Elements which are not to be repaired or restored and shall landscape and restore such area to a clean, safe and attractive condition, and the Board of Directors shall have the right to levy a special Assessment against all of the Owners of the Condominium Units to raise the funds necessary to

defray the costs of such work in excess of any ambuits which was available from any reserve funds of the Association of the interest for such purpose.

- 9.2 Manner of Repair and Reconstruction. All repairs, reconstruction or rebuilding to be made as a consequence of a fire or other casualty shall be made in accordance with the following provisions:
- 3.2.1 Common Elements. If the damage reconstructed is to the Common Elements, to. be repaired or proceeds payable as a result of such damage or destruction is less than (10%) of the total annual revenues anticipated to be received by the Association under the then current budget of the Association, such repair or reconstruction shall be substantially in accordance with the plans and specifications for such damaged property prior to the occurrence of such damage, or in accordance with such different plans and specification as may be approved for such purpose by the Board of Directors. If the damage to be repaired or reconstructed is to the Common Elements, and if the insurance proceeds available as a result of such damage or destruction is greater than ten percent (10%) of the total annual revenues anticipated to be received by the Association under the then current budger of the Association, such repair or reconstruction shall be substantially in accordance with the plans and specifications for such damaged property prior to the occurrence of such damage, or in accordance with such different plans and specifications as may be approved for such purpose by the Board of Directors; provided, however, that in the event the Board of Directors shall approve plans and specifications for the repair or reconstruction of such damaged property which differ materially from those of the damaged property prior to the occurrence of such damage, such plans and specifications shall be submitted for the approval of a majority of the Association, if a request to such effect is submitted in writing signed by Owners together possessing at least fifteen percent (15%) of the total Vote of the Association no later than 14 days after the meeting at which the Board of Directors approve such differing plans and specifications.
- 9.2.2 Units. If the damage to be repaired or reconstructed is to any Unit, such repair, reconstruction or rebuilding shall be substantially in accordance with the plans and specifications for such damaged Unit prior to the occurrence of such damage.
- 9.2.3 Responsibility for Repair or Reconstruction. All of the work of repairing or reconstructing any portion of the Submitted Property, the damage to or destruction of which resulted in the payment of any insurance proceeds under any insurance policy maintained by the Association, shall be the responsibility of the Association and shall be performed under the supervision of the Board of Directors. In discharging such supervisory responsibility, the Board of Directors shall be authorized, but shall not be obligated, to employ as its agent or consultant such building supervisors or architects as the Hoard

of Directors shall determine. Any fees which and the payable to any such building supervisor or architect as shiply de employed by the Board of Directors shall be a Common Expense of the

# 9.3 Costa of Repair and Reconstruction.

- Former Elements. The costs of repairing or reconstructing any portion of the Common Plements not exclusively serving any Unit which shall be damaged or destroyed shall be paid with any insurance proceeds which shall be paid to the Association on account of such damage or destruction. If such insurance proceeds, together with any amounts as may be available from any reserve funds maintained by the Association for such purposes, are not sufficient to defray such costs of repair or reconstruction, the Board of Directors shall levy a special Assessment against funds necessary to defray such costs.
- The costs of repairing or reconstructing each Unit which shall be damaged or destroyed, together with any portion of the Common Elements exclusively serving such Unit which shall be damaged or destroyed, shall be paid with the insurance proceeds which shall be paid to the Association on account of such damage or destruction for such Unit. If any amounts shall remain after all of the costs and expenses of repairing and reconstructing the Unit are paid, such amounts shall be paid jointly to the Owner and his mortgages. - 9.3.3 Common Elements Exclusively Serving a Unit. This concept is necessary because almost all structural parts of a building technically constitute Common Elements under the Unit boundaries established in Section 3.3 of this Declaration.

### ARTICLE 10

# ARCHITECTURAL CONTROL, USE RESTRICTIONS AND SALE OR LEASING OF UNITS

To assure a community of congenial Owners and thus protect the value of the Condominium Units, the Submitted Property shall be subject to the restrictions set forth in this Article and in the rules and regulations of the Association.

- architectural appearance of the Condominium, no construction the painting or other changes of any nature wheath wer invited with respect to the exterior of any Unit or any other portion of the condominium. including any Limited Common Elements appointement therate, nor shall any interior or exterior addition to or change or alteration therein be made which in any way affects the exterior appearance of a Unit, unless and until the plans and specifications showing the nature, kind, shape, color, haight, materials and location of the same shall have been submitted and approved in writing as to harmony of external design and location in relation to surrounding structures and topography by the Board of Directors or by an architectural committee appointed by the Board of Directors. An Owner may make improvements and alterations within his Unit; provided, however, that up Owner shall make any structural alterations in a Unit or remove any portion thereof or make any additions thereto or do anything which would or might jeopardize or impair the safety, soundness or structural integrity of that Unit or any other Unit or otherwise materially lessen the support of any portion of the Condominium. No Owner shall impair any easement without first obtaining the written consent of the Association and of the Owner or Owners and their Mortgagees for whose benefit such easement exists. Any alteration or impairment of the easements granted to or reserved, by the Declarant or the Firate's Cove Homeowners' Association, Inc. shall first have the approval of the beneficiary of such easement.
- 10.2 Lighting. The design, type, location, size, intensity and color of all exterior lights (including both those mounted as part of the original design of the Submitted Property or Otherwise in place at the time of the conveyance of a Unit to an Owner and those mounted with the consent of the Board of Directors) shall be subject to the prior written approval of the Board of Directors:
- 10.3 Peridential Physoses. Except for Declarant's rights as set forth herein, all units shall be, and the same hereby are, restricted exclusively to single-family residential use, and the occupancy thereof shall be subject to such restrictions as the Board of Directors may establish pursuant to the rules and regulations of the Association. As used nerein, the term "single-family" shall mean (1) a group of natural persons related to each other by blood or legally related to each other by marriage or adoption, or (3) a group of not more than three (3) persons not so related who maintain a common household in a Unit. This paragraph shall not, however, prevent a corporation, partnership, or other entity from owning a Unit.
- 10.4 Susiness Activities and Signs. No business activities, other than the development and sales activities of Declarant as permitted hereunder, shall be conducted on any pertion of the Submitted Property. Except as may be required by legal proceedings and except as permitted in accordance with Section

- 4.8 hereof, so "For Sale" or "For Rent" signs delethed the advertising posters of any kind shall be maintained or permitted on any portion of the Submitted Property. Notwithstanding the foregoing, the provisions of this Section shall not apply to any signs maintained on the Submitted Property by Declarant, its agents, representatives or assigns, during the period that Declarant has any Condominium Unit for sale, or to the First Mortgages of any unit pursuant to a Foreclosure Sale.
- generally recognized house pets (excluding pet fish in an aguarium) shall be kept or maintained on any portion of the Submitted Property and then only if they are kept or maintained solely as domestic pets and not for commercial purposes. No pet shall be allowed to make an unreasonable amount of noise or to become a nuisance. We structure for the care, housing or confinement of any pet shall be constructed or maintained on any part of the Common Elements or Limited Common Elements. Data shall be on leash when walked or exercised in any portion of the Common Elements. No pets shall be permitted to leave its droppings on any portion of the Common Elements and the Owner of such pet shall immediately remove the droppings. Upon the written request of any Owners, the Epard of Directors may conclusively determine, in its sole and absolute discretion, whether, for the purposes of this Section, a particular pet is require the Owner of a particular pet to remove such pet from the Condominium if such pet is a nuisance and shall have the right to require the Owner of a particular pet to remove such pet from the Condominium if such pet is found to be a nuisance or to be in violation of these restrictions. The Board of Directors may allow for a third pet in a particular instance at its sole discretion, but such shall not be deemed a waiver of the 2-pet limit herein established. The use and enjoyment of the Common Elements by the Owners and their Occupants shall be subject to such reasonable rules and regulations as may be made and amended from time to time in accordance with Section 7.5 of this Declaration. This Section is for the mutual benefit of all Owners and is necessary for the protection of all Owners.
- 10.7 Antennas. No antenna or other device for the transmission or reception of television signals, radio signals or any form of electromagnetic wave or radiation shall be erected, used or maintained outdoors on any portion of the Submitted Property, whether attached to a building or structure or otherwise, without the prior written consent of the Board.
- 16.3 Motor Vehicle, Trailers, Boars, Rtg. Automobiles shall be operated and parked only upon those portions of the Common Elements designated for such purpose on the Flat, Plans or by the Board of Directors. Other motor vehicles, including, without limitation, mobile homes, motor homes, truck campers, trailers of any kind and boats, shall be kept, placed, stored,

- dumped, placed, or permitted to accumulate upon any portion of the Submitted Property, except in containers specifically designated for such purpose, nor shall any odors, be permitted, so as to render any portion of the Submitted Property unsanitary, unsightly, offensive or detrimental to persons using or occupying other portions of the Submitted Property. No nuisance shall be permitted to exist or operate upon any portion of the Submitted Property so as to be offensive or detrimental to persons using or occupying other portions of the Submitted Property. All Woit Owners shall acknowledge, adhere to, and domely with any and all such governmental regulations, including the provisions of the Coastal Area Management Act and the regulations of the Division of Environmental Management. In the event of any conflict between any provision of any such governmental code, regulation or restriction and any provisions of this Declaration, the more restrictive provisions shall apply.

Except as otherwise allowed under 47C-2-117 of the Act and as permitted herein, this Declaration may be amended at any time and from time to time by the affirmative Wote of Owners having at least two-thirds (2/3rds) of the total Votes of the Association; provided, however, that during such time as Declarant has the right to appoint and remove members of the Board of Directors and Officers pursuant to Section 7.2 such amendment shall require the agreement of both Declarant and Owners to which two-thirds (2/3rds) of the Votes in the Association appertain, exclusive of any Vote or Votes appertaining to any Condominium Unit or Units then owned by Declarant. So long as the same shall not (a) adversely affect the title to any Condominium Unit, (b) change the percentage of undivided ownership interest in and to the Common Elements appurtenant to any Condominium Unit, (c) materially alter or change any Owner's right to the use and or enjoyment of his Unit or the Common Elements as set forth in this Declaration, or (d) otherwise make any material change in

this Declaration, each Owner agrees that, if remested decide so, such Owner will consent to the amendment of ith Companion Instruments, (i) if such amendment is necessary to oring any provision hereof or thereof into compliance or conformity with. or remove any conflict or inconsistency with, the provisions of any applicable governmental statute, rule, regulation, including without limitation the provisions of the Act. or judicial determination which shall be in conflict therewith. (ii) if such amendment is required by the governmental statutes, laws, rules or regulations applicable to or promulgated by a governmental lender or purchaser of mortgage loans, including, for example, the Federal National Mortgage Association. Federal Home Loun Mortgage Corporation, Veterans Administration on Federal Housing Administration, to enable such lender or purchaser to make or purchase mortgage loans on any Condominium Unit, or (iii) if any such amendment is necessary to enable any governmental agency to insure mortgage loans on the Condominium Units based on the statutes, laws, rules or regulations applicable to or promulgated by such agency. Except as expressly permitted or required by the Act and this Declaration, any amendment to this Declaration. Act and this Declaration, any amendment to this Declaration the which would change the boundaries of any Unit, the undivided interest in the Common Elements, the number of Votes in the Association or the liability for Common Expenses appartaining to any Condominium Unit shall be approved in writing by all Owners. Any provisions in this Declaration which may construed, to the contrary notwithstanding, any amendment to this Declaration, which would change, alter, modify or reacind any right, title, interest or privilege herein expressly granted to any Mortgagee shall require the prior written approval of such Mortgagee. Amendments to this Declaration or the other Condominium Instruments may be proposed by Declarant, by the Board of Directors, or by petition signed by Owners having at least thirty percent (30%) of the total votes of the Association. Agreement of the required majority of Owners to any amendment of the Condominium Instruments shall be evidenced by their execution of the amendment. Any such amendment of the Condominium Instruments, including this Declaration, shall become effective only when recorded or at such later data as may be specified in the amendment itself. The written consent of any Mortgages required with respect to such amendment shall also be recorded with such amendment.

- Submitted Property shall be taken by any authority having the power of eminent domain, the allocation of the award for such condemnation and all related matters, such as the reallocation of undivided interests in the Common Elements, liabilities for Assessment and Votes, shall be handled as follows:
- 11.2.1 If any Unit or portion thereof or the Common Plements or any portion thereof is made the subject matter of any condemnation or eminent domain proceeding or is otherwise sought to be acquired by a condemning authority, then the helder of any First Mortgage on a Condominium Unit will be entitled to timely written notice of any such proceeding or proposed acquisition.

- 11.2.2 In the event all or any part of the Submitted Property shall be taken in condemnation or by eminent domain, each Owner hereby grants an invevocable power of attorney to the Association to represent such Owner in any and all condemnation proceedings, negotiations, settlements and agreements with the condemning authority. The award for such taking shall be payable to the Association for the use and benefit of the Owners and their respective Mortgages as their interest may appear and shall be disbursed by the Board as hereinafter provided.
- 11.2.3 If the taking is confined to the Common Elements, the Board of Directors shall arrange for restoration of the remaining Common Elements and the Board of Directors shall disburse the proceeds of the condemnation award in the same manner as required for the disbursement of insurance processs where damage or destruction to the Common Elements is to be repaired or reconstructed, as provided in Article 9 hereof.
- 11.2.4 If the taking includes any part of a Unit, whether or not there is included in the taking any part of the Common Elements, such taking shall be deemed to be and shall be treated as damage or destruction which shall not be repaired or reconstructed as provided in Article 9 hereof, whereupon:
- (i) The Board of Directors, using the proceeds of such condemnation award, shall acquire, on behalf of the remaining Owners, the Condominium Unit or Units of the Owner or Owners whose Condominium Unit or Units have been taken in whole or in part, at a price equal to the fair market value of such Condominium Unit or Units as of the date immediately preceding the condemnation thereof. Such price shall be determined by majority vote of three (3) appraisers, one of whom shall be selected by the Owner or Owners affected, one of whom shall be selected by the Board of Directors and the third of whom shall be selected by the two (2) appraisers so selected. All appraisers so selected shall be members of the American Institute of Real Estate Appraisers or any successor association or body of comparable standing if such institute is not then in existence), disinterested, have at least ten (10) years experience in the appraisal of real estate, be familiar with property values in Dare County, North Carolina, and have some experience in the appraisal of Condeminium Units.
- (ii) After acquisition of the Condominium Unit or Units as aforesaid, the undivided interest in the Common Elements, Votes of the Association and share of liability for Common Expanses apportaining to such Condominium Units shall thenceforth appertain to the remaining Condominium Units on the basis of an equal share per Unit. The method of distributing the remainder of

the condemnation award, if any, shall be determined by the Spard of Directors.

- 11.3 Rights of Third Parties. This Declaration shall be recorded pursuant to the provisions of the Act for the benefit of Declarant, the Owners and their Mortgagees as hereis provided, and by such recording, the Owners shall not have the right to cancel, extend, modify, amend or otherwise change the provisions of this Declaration without the consent, permission or approval of any adjoining Owner or third person.
- 11.4 Remination. The Common Elements shall remain undivided, and unless the Condominium form of ownership hereby established is tarminated in accordance with Section 47C-2-118 of the Act, no Gwner nor any other person shall bring any action for partition or division of the whole or any part of any Condominium Unit or of the whole or any part of the Common Elements. The Condominium may be terminated or abandoned only by the agreement of all Owners, provided that all holders of Mortgages encumbering the Condominium Units consent thereto and agree if required by Section 47C-2-118 of the Act.
- 11.5 Enforcement. Each Owner shall comply strictly with the provisions of the Condominium Instruments and rules and regulations of the Association. In the event of a violation or breach, or threatened violation or breach, of any of the same, the Association or, in a proper case, any aggrieved Owner or Owners, jointly and severally, shall have the right to proceed at law or in equity to compel compliance therewith or to prevent a threatened violation or breach thereof. In addition to all other remedies, the Association, or a duly authorized agent thereof, shall have the right to enter upon any portion of the Common Elements including any Limited Common Elements, where a violation exists and, at the expense of the violating Owner, abate or remove any erection, thing or condition that may be or exist contrary to the intent and meaning of the Condominium Instruments or rules and regulations, if after notice and hearing as set forth in the Bylaws, it shall not have been corrected by such Owner. Neither the Association, nor its agents, shall be deemed guilty or liable for any manner of trespass for such entry, abstement or removal. Should the Association employ legal counsel to enforce any of the foregoing or any other rights or remedies of the Association, all costs incurred in such enforcement, including a reasonable fee for counsel, shall be paid by the violating Owner. Inasmuch as the enforcement of the provisions of the Condominium Instruments and rules and regulations is essential for the protection of present and future Owners, it is hereby declared that any breach thereof cannot be adequately compensated by recovery of damages, and that the Association or, in any proper case, any aggrieved Owner or Owners, in addition to all other remedies, may require and entitled to the remedy of injunction to restrain any such violation or breach or threatened violation or breach. No delay, failure or emission on the part of the Association or any aggrieved Caner or Camers in exercising any right, power or remedy

berein provided shall be construed as an acquisacence thereto or shall be deemed a waiver of the right to do so thereafter as to the same violation or breach, or as to a violation or breach occurring prior or subsequent thereto, and shall not bar or affect its enforcement. No right of action shall accrue nor shall any action be brought or maintained by anyone whatsoever against the Association or its. Officers or Directors for or on account of any failure to bring any action on account of any violation or breach, or threatened violation or breach, of the provisions and regulation, however long continued, or for the imposing of provisions which may be unenforceable.

- 11.6 Exhibits. All exhibits referred to in and strached to this Declaration or any other Condominium Instrument are hereby incorporated in this Declaration or such other Condominium Instrument, by this reference.
- 11.7 Euration. Unless the Condominium is terminated as provided herein or in the Act, the provisions of this Declaration shall run with and bind the land, shall be binding upon and inure to the benefit of all Owners and Mortgagess, their heirs, executors, legal representatives, successors and assigns, and shall be and remain in effect perpetually to the extent permitted by North Carolina law.
- 11.8 Interpretation. In all cases, the provisions set forth or provided for in this Declaration shall be construed together and given that interpretation or construction which, in the opinion of Declarant or the Board of Directors, will best effect the intent of the general plan of the Condominium. The provisions hereof shall be liberally interpreted, and if necessary, they shall be so extended or enlarged by implication as to make them fully effective. The effective date of this Declaration shall be the date it is filed for record. In the event of any conflicts or inconsistencies between the Act, this Declaration or the Bylaws, the terms and provisions of the Act and this Declaration, in that order, shall prevail.
- 11.9 Gender and Grammar. The singular wherever used herein shall be construed to mean the plural when applicable, and the necessary grammatical changes required to make the provisions hereof apply either to corporations or other entities or to individuals, men or women, shall in all cases be assumed as though in each case fully expressed.
- 11.10 Rights of Mortgagees and Unit Owners. In addition to the rights of Mortgagees elsewhere provided, each Mortgagee shall:

  (a) be entitled to written notice from the Association of any default by the Owner of the Unit mortgaged in the performance of his obligations under the Condominium Instruments which is not cured within sixty (60) days, specifically including any delinquency in payment of an Assessment; (b) be entitled to receive notice of and to designate a representative to attend and observe all meetings of Owners, but not meetings of the Board of Directors; (c) be entitled to receive written notice of any

condensation loss or any casualty loss which affects a material portion of the Condominius or any Unit on which a Mortgages helds a Mortgage; (d) be entitled to receive thirty [38] days office written notice of any lapse, cancellation or material [6] difficulties of any insurance volicy or fidelity bond maintained by the Association; (a) be estitled to receive written notice of any proposed action which would require the consent of a specified percentage of the Mortgages; and (f) be furnished copies of about financial reports within 120 days after the end of the Association's fiscal year; provided, however, that such Owner or Mortgages shall first file with the Association a written request (setting forth the name of such Owner or Mortgages and the Unit Besignation of the Unit with respect to which such request is made) that notices of default, notices of meetings and copies of financial reports be sent to a named agent or representative of the Mortgages or Owner at an address stated in such notice. Further, each Mortgages and Unit Owner shall, upon request, be entitled to inspect the books, records, and financial statements of the Association (including the Condominium Instruments and other documents) during normal business hours. Any First Mortgages shall, upon written request, be entitled to a financial statement of the Association for the immediately preceding fiscal year.

- 11.11 Savarability. Whenever possible, each provision of this Declaration shall be interpreted in such manner as to be effective and valid, but if the application of any provision of this Declaration to any person or to any property shall be prohibited or held invalid, such prohibition or invalidity shall not affect any other provision or the application of any provision which can be given effect without the invalid provision or application, and to this end the provisions of the Declaration are declared to be severable.
- 11.12 Captions. The captions of each Article and Section hereof refers to its contents and are inserted only for convenience and are in no way to be construed as defining, extending or otherwise modifying or adding to the particular Article or Section.
- anything to the contrary contained in the Condominium Instruments, except as provided by the Act in case of substantial loss to the Units or termination and as provided herein in the case of condemnation, partition or in the case of substantial loss to the Common Elements, unless at least two-thirds (2/3rds) of the First Mortgagees (based upon one vote for each first mortgage owned) and Owners (other than the Declarant) of the Condominium Units have given their prior written approval, neither the Association nor the Owners shall be entitled to:
- 11.13.1 Except for special Assessments levied pursuant to Section 6.3 hereof, and except for the distribution of hazard insurance proceeds pursuant to paragraph 9.3.3 hereof, change the pro rata interest or obligations of any Condominium Unit for the

purpose of: (i) levying Assessments or charges and allocations distributions of hazard insurance proceeds on annotament on awards, or (ii) determining the pro rate share of [0] nership to each Condominium Unit in the Common Elements.

11.12.2 By act or omission, seek to encumber, sell or transfer the Common Elements, except in the case of reassignment of Limited Common Elements pursuant to Section 3.5 hereof (neither the granting of easements for public utilities or for other public purposes consistent with the intended use of the Common Elements by the Condominium nor the transfer, sale or encumbrance of an undivided interest in the Common Elements, as an appurtenance to a Unit, shall be deemed a transfer within the meaning of this subparagraph).
